8. Wild about the Woods /Stronger Communities

a) Update from Will Watts, Hidden Horizons

WW had circulated his update report to the Board.

The key points to note are:

- Toad Patrol sessions at Throxenby Mere now finished
- Struggled with numbers on the Volunteer Saturdays but the sessions with Sidewalk and Starfish (Young Carers) groups, and the Archaeology Walks groups have been very successful.
- The Dawn Chorus Walk attracted 20 people.
- The Saturday Woodland Explorer Clubs are oversubscribed.
- Overall over target in terms of engagement and numbers for the Wild about the Woods Project.

Future events:

- Regular free drop in forest activity session for families, to be held every Tuesday and Friday during the summer holidays, marketed to Northstead and Barrowcliff families via schools.
- Summer club workshops with Gallows Close this will include sessions at Gallows Close and some in the woods.
- Three one day bushcraft sessions to be offered free to Barrowcliff and Northstead residents as part of the Wild about the Woods project.
- Archaeology events as part of the Festival of British archaeology and Heritage Open Days events.

WW outlined the proposed spend for the remaining WATW budget including buying IT kit for future use of RWCE and spend on training for young people. WW will action.

For the training element of the funding WW proposed a summer 'intern' scheme which would be open to Barrowcliff and Northstead residents over 16 years of age. They would work with Hidden Horizons delivering events and activities and would be paid a small bursary. They would receive training in all relevant areas and would get a certificate on completion of the scheme. This would be great experience for those taking park and could potentially provide RWCE with a pool of people to work with moving forward.

The Board **AGREED** the spend and were fully supportive of the summer 'intern' scheme project. WW will take forward.

- DE has been in contact with NYCC about the bridleway via Raincliffe House/Row Brow Farm which is currently blocked. NYCC are speaking to the land owners to get it reinstated.
- RB thought that the Right to Roam had ceased to exist and that applications needed to be made to get the paths remapped. RB has application forms and will send to RS.
